IN THE MATTER OF THE MINISTRY OF FOREIGN AFFAIRS, US VISA FRAUD AND TREASON Suit No. FHC/ABJ/CS/1774/2025 OPEN LETTER TO THE CHIEF JUDGE: URGENT NEED TO RECONSIDER DIPLOMATIC RELATIONS WITH THE WEST, INCLUDING THE EUROPEAN UNION AND CANADA

Milord,

In the course of litigating this action, I have had recourse to the Blessed Mother, Queen Mary, such that during my pilgrimages across Europe, my eyes have been opened to the glaring existential racism in Western nations and in particular Italy. I've been first hand了解到 the world of demonic convents by Western world powers seeking to create an enabling environment of despondency in Africa so as to coerce its ruling elite to "save themselves" as a way out of poverty. What do I mean?

In 1993, on an excursion to Germany, my father, L.E Nwosu (SAN) got into a swimming pool with his wife, and all the White people got out in protest. In 2025, 23 years later, I am brazenly being denied accommodation/airlines in Italy, France and Canada on account of my race. On an air Canada flight AC89 on 23rd December 2025, I was told to leave the plane because their air hostess, Lynn Dwyer, did not want my black face in business class. I opted to file a criminal complaint, and the Italian police said that I should wait for the captain's report, they will contact me, they haven't contacted me. Air Canada did nothing, but open a ticket that will die in the dungeon of discrimination bureaucracy like my last complaint. In the West, I am led to that hotel rooms are unavailable on bookings I have prepaid, while the hotel staff proceeds without shame or reservation to check in other White guests, as in the case of Hotel Locarno, Hotel Nolinski the Waldorf Astoria, NunAsesi hotels, Italy. I am denied access to facilities, wherein the staff rise in the morning to close facilities. I have pre-booked to use, as in the case of ViewPlace Hotel in Aprona. In fact when I ordered a "slice of fish" from the menu, I was served octopus, meanwhile my dog was given the slice of fish fillet. Italy is a site of religious pilgrimage for Catholics. However it appears racism is back in full force under Meloni, and has perpetrated the religious walls and courts of law such that there is no separation of church and state. For example, my lawsuit denouncing the race based discrimination of African descendants by the ecclesiastical Catholic Community of the Beatitudes, whose psycho-manipulative leaders were convicted in France, was muffed by White racist judges in the District Court of Colorado, California and Washington, DC. See Nwosu v. Bolduc et al.

In these lawsuits and throughout my voyages in the West, one readily perceives how dominionally possessed racist Westerners are. This is especially true in Italy, Italy, Italy, where the racism is so pointless, it's stupifying. In the words of the chanteuse Ms Nina Simone, "Italy! Hot damn!" Truly the poor shouldn't have servants, and children should not have kids. How Italy is a G7 country beats me: the people are undereducated, lazy, corrupt, and excessively licentious. We must ban Nigerians from migrating to Italy to work as anything less than top class professional such as doctors or lawyers, because to live in Italy as a nurse or maid, is to be a slave in an impoverished country of weird spirit.



Mrs Johnson had to miss the January 6 2026 Epiphany celebration and closing of the Holy Door of Saint Peter's basilica, because Marco, senior receptionist staff at Hotel Locarno Italy ILLEGALLY denied her accommodation, by stating the hotel was fully booked, though her booking was prepaid. Marco, pictured proceeded to check in White guests. Expedia, Inc, who has been motioned for a joinder to this suit, refused to de-list the property though the property violated their terms by discriminating based on race. Expedia also refused to delist Hotel Nolinski, in Paris, which is a conduit for sex trafficking for wealthy Arabs, although the claimant filed the police report of what she witnessed and sent to Expedia. These "5 star" hotels want to see your Black face mopping their floors, instead of serving you. Expedia is owned by the demonic finance house BlackRock, Inc, whom Mrs Johnson had sued alongside Bill Gates Cascade Investments for discriminating against Nigerians and surcharging them in his Four Seasons Hotel. See Nwosu vs. Cascade Investments, LLC, 9th circuit court of Appeals. Stop booking with Expedia, Trip Advisor, booking.com as they scrub their reviews of discrimination complaints and don't protect Black consumers.

advancing, top brands like the Hilton Worldwide Inc, are at the spearhead of advancing the demonic agenda of homosexuality and licentiousness, and Black poverty. These hotels, including Marriott, and Accor owners of the Fairmont, Washington DC, discriminate by surcharging Black people, and yet they are operating in Nigeria for their profits. Besides being racist institutions, they also promote pornography, child molestation, under the guise of art, as they take pride in displaying the bodies of naked children in their hotels, as in the case of the Waldorf Astoria in Rome, the Four Seasons Hotel owned by Bill Gates and Arab donors. What's more is that these hotels are fraudulent, and use cheaply renovated products, you would think you're in Alaba after shelling out. For example, in France, I stayed at a fraudulent Hotel Westminster on 13 Rue de la Paix, where my ring was stolen, and their tolls, broke because they refused to heat their bathroom, yet France's Atom. France regulation agency ranks it as 5 star to steal money! They can't regulate their own people and yet they are regulating you. Till date although the police stated firmly the hotel is liable by law to replace it, the hotel's insurance has suspended my payout indefinitely. Yet to obtain visas, these EU countries make us purchase their expensive insurance and make Nigerians jump through all manner of useless hoops. You following the Ponzi scheme? No lawyer in France will take the discrimination case, and there are hardly any Black lawyers in France now, why? It takes a cycle of 100 years, approximately two generations, for immigrant maid's grand child or great grand child to have surmounted the challenges associated with poverty and racism (living in violent neighbourhoods, affording only a lower class education, distracting friends, inadequate meals); to obtain a professional degree in Europe, and by that time, the statute of limitations is gone.

Discrimination is a form of abortion as it is a personal attack against the life of the innocent and inherently violates the dignity of the person. It is anti-Catholic and anti-Christ. So there's no difference between Kanala Harris who is pro-abortion and Donald Trump who is racist. Furthermore, although the Western countries all have anti-discrimination laws, the laws are not enforced. In fact, they discriminate, impoverish and outrightly kill

control. Thus they introduce viruses through medicine and food. Lobbyists for abortion and contraception, such as Bill Gates bring contraception and vaccines as a form of population control under the Bill & Melinda Gates foundation. They also control what you eat. For example Gates's Green Africa initiative promote genetically modified seedlings that profit pharmaceutical

industries like Bayer, which its institutional investors, like BlackRock, Inc, owns3. Uneducated African leaders put innocent souls in trouble by allowing the West to control their agriculture, under various nefarious "aid" programs AI, GMO, green technology etc scam programs. It is no secret that the American CIA, in the 1970's through Satanic Scottish doctors experimented with how to alter the brain, through food and religion, to increase one's propensity to become homosexual. Since Germans don't want to promote real industrialisation but continue to extract from Nigeria, Nigeria needs to close down the German Kellogg factory, built under its GIZ's "agricultural program". They use its development agency GIZ as a backdoor to scout for minerals, as they're simply pushing their finished consumer products into Nigeria, competing unnecessarily with Nigerian manufacturers like NASCO. Meanwhile, these EU countries create all manner of useless regulations to prevent Nigerian exports to their countries. Thus, we must ban the importation of finished EU consumer products into our country because these nations strategically do not wish to produce in Nigeria, under the guise of lack of security, though they cause the conflict. The airlines like Lufthansa German airline who do not wish to partner with Nigerian brands must carry their load and go, and stop surcharging Nigerians spectacularly on airfares and requiring we buy transit visas, to fund their embassies.

Nigeria must also ban the UK imposed visa system. Visas are a war tool and a form of control. It was started by the UK during WW1 to regulate the entrance of potential enemies. Thus the practice that requires Africans to come naked to embassies with their bank accounts, to show that they
